2. Submission of BCC/Occupancy Certificate.
3. The school shall comply with the provisions of DSEAR, 1973 RTE Act, 2009 and directions/instructions issued by the department from time to time and judicial pronouncement w.r.t. maintenance/utilization of school funds.
4. The school shall comply with the provisions of Rule 176, 177, 18(5), 17(3) & order dated 15.12.1999, 10.05.2005, 11.02.2009, 16.04.2010 & 19.02.2016 dealing with the regulation of fee alongwith the sub sequent orders issued by DoE from time to time.
5. School shall Make Payment of salary to the staff as per section 10(1) of DSEAR, 1973.
6. Salary to the staff should be made through crossed Electronic Clearance System(ECS).
7. A certificate from the competent authority that the building has been constructed as per National Building code 2005 within three months.
8. That all the facilities prescribed under section 4 of DSEAR 1973 read with rule 50 & 51 DSEAR 1973 shall be made available to the students.
9. That the school shall admit the students without any discrimination of religion race, caste or place of birth as per the norms of the Department.
10. The managing committee shall regulate the functioning of school strictly in accordance with the provisions of DSEAR 1973 and RTE Act, 2009.
